- 5. To request the correction of your personal data if it is incomplete or incorrectly processed
- 6. To request the deletion or destruction of your personal data within the scope of the conditions stipulated in Article 7 of the PDPL
- 7. If your personal data is deleted or destroyed within the scope of Article 7 of the PDPL and your personal data is incomplete or incorrectly processed, to request the notification of the third parties to whom the personal data has been transferred
- 8. To object to the emergence of a result against you due to the analysis of your personal data exclusively by automated systems,
- 9. To request compensation of the damage in case you suffer damage due to unlawful processing of your personal data

In accordance with Article 13 of the PDPL, GetirDrive will finalize your requests within 30 (thirty) days at the latest, depending on the nature of the request. If the transaction requires cost, the tariff determined by the Personal Data Protection Board will be applied. If your request is rejected, the reason(s) for the rejection will be communicated to you within 30 (thirty) days at the latest.
