GetirJobs - Privacy Notice

As Getiriş Danışmanlık ve Ticaret Anonim Şirketi ("**GetirJobs**"), we take utmost care to process and protect the personal data of our customers, in accordance with the Personal Data Protection Law No. 6698 ("the **PDPL**"), its secondary legislation and decisions of the Personal Data Protection Board. We have prepared this privacy notice ("**Notice**") to inform you about how we process your personal data as a data controller through GetirJobs mobile application ("**Application**") managed by GetirJobs.

GetirJobs presents the Application that aim to gather job seekers and employee seekers on the same platform. The Application users may discover the job opportunities closest to them, postings as job seekers or employers, and communicate with each other through the Application.

We collect your personal data by means of fully automatic and partially automated methods, via the Application, call center, and e-mail if you contact us via e-mail. We process your personal data based on the legal reasons set forth in Article 5 of the PDPL. Your Rights Regarding Your Personal Data

Article 11 of the PDPL regulates your rights as a data subject as described hereinbelow:

To learn whether your personal data are processed or not,

To request information about the processing of your personal data,

To learn the purpose of the processing of your personal data and whether your personal data are used in compliance with the purpose,

To know the third parties to whom your personal data are transferred domestically or abroad,

To request the rectification of the incomplete or inaccurate personal data, if any,

To request the erasure or destruction of your personal data under the conditions referred to in Article 7 of the PDPL,

To request reporting of the operations carried out pursuant to sub-paragraphs (d) and (e) of the Article 11 to third parties to whom your personal data have been transferred,

To object to the occurrence of a result against yourself by analyzing the data processed solely through automated systems,

To claim compensation for the damage arising from the unlawful processing of your personal data.

How to Use Your Rights Regarding Your Personal Data

In accordance with Article 13 of the PDPL, Getir will finalize your requests within **30 days at the latest**, depending on the nature of the request. If the transaction requires cost, the tariff determined by the Personal Data Protection Board will be applied. If your request is rejected, the reason(s) for the rejection will be communicated to you within **30 (thirty) days at the latest.**
